#### RECORDS: OPERATORS OF AUCTION SALES AND BROKERS.

Every operator of an auction sale or broker shall make, keep, and maintain records or forms which fully and correctly disclose the required information concerning each animal consigned for auction or sold, whether or not a fee or commission is charged.

One copy of the disposition form (form 7006) went to the buyer and two copies of the disposition forms (form 7006) were returned to the consignor. The required information was not retained by the license holder.

Failure to maintain the required records does not allow for the proper tracking of dogs by an APHIS official.

The required records shall be maintained and available for review. To be corrected: from this point forward. Number of animals affected: 219.

#### PRIMARY ENCLOSURES USED TO TRANSPORT LIVE DOGS AND CATS.

Cleaning of primary enclosures. A primary enclosure used to hold or transport dogs in commerce must be cleaned and sanitized before each use in accordance with the methods provided in Sec. 3.11(b)(3) of this subpart.

The enclosures used to containing the dogs had not been cleaned and sanitized prior to their use. Dried bedding and animal waste could be seen in some of the enclosures. There were dust and bird droppings on some of the enclosures.

Failure to clean and sanitize enclosures between uses does not protect the health and well being of the animals.

Enclosures must be cleaned and sanitized prior to use. To be corrected: From this point forward. Number of animals affected: 219.

### **PRIMARY ENCLOSURES USED TO TRANSPORT LIVE DOGS AND CATS.**

Space and placement. Primary enclosures used to transport live dogs must be large enough to ensure that each animal contained in the primary enclosure has enough space to turn about normally while standing, to stand and sit erect, and to lie in a natural position.

Four Shetland Sheep Dog puppies (numbered 142, 143, 144, and 145) were housed in pet carrier type enclosure during the auction. The enclosure was approximately 16"X24". The puppies were not able to lie in a natural position. The puppies were observed resting their heads on one another as there wasn't sufficient space to rest their heads on their paws or on the floor of the enclosure.

This does not provide for the comfort and well being of the dogs.

Dogs consigned into the auction must be provided adequate space. To be corrected: from this point forward.  
Number of animals affected: 04.



#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Each dealer or shall establish and maintain a program of adequate veterinary care that includes the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries.

Dog 3 (a Boston Terrier) had a bright red, fleshy protrusion in the corner of its left eye. Dog 4 (a Boston Terrier) had the same type of condition in both of its eyes. The dogs were consigned into the licensee holder?s auction and subsequently sold via the auction.

Selling dogs that have not received the appropriate veterinary care does not provide for the health and well being of the dogs.

Dogs must be evaluated by the veterinarian to determine the status of the dogs health, the appropriate treatment, and its suitably for sale. This item must be corrected at all future auctions. Number of animals affected: 02.

### 2.132 (d)

#### PROCUREMENT OF RANDOM SOURCE DOGS AND CATS, DEALERS.

No dealer or exhibitor shall knowingly obtain any dog, cat, or other animal from any person who is required to be licensed but who does not hold a current, valid, and unsuspended license. No dealer or exhibitor shall knowingly obtain any dog or cat from any person who is not licensed, other than a pound or shelter, without obtaining a certification that the animals were born and raised on that persons premises and, if the animals are for research purposes, that the person has sold fewer than 25 dogs and/or cats that year, or, if the animals are for use as pets, that the person does not maintain more than three breeding female dogs and/or cats.

Three consigning individuals presented dogs for auction and were not required to certify that they did not need to otherwise be USDA licensed.

Failure to obtain this certification does not ensure that the consigning individuals are not required to be USDA. Further, it does not ensure that those animals are being inspected to check for compliance with the regulations and standards to protect their health and well being when they should be.
